- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, and officials at every game, practice, or other youth sports events.
- I will place the emotional and physical well being of any child ahead of a personal desire to win.
- I will support coaches and officials working with any child, in order to encourage a positive and enjoyable experience for all.
- I will remember that the game is for the youth and not for the adults.
- I will help any child enjoy the sport experience by doing whatever I can, such as being respectful to the fans, assisting with coaching, or providing the basics of football.
- I will ask any child to treat other players, coaches, fans, and officials with respect regardless of race, sex, creed, or ability.
- I will conduct myself in a gentleman-like manner at all times. (Misconduct will cause for dismissal or suspension from the S.F.Y.F.L.)
- I will accept all decisions from the S.F.Y.F.L. as a final judgment.

THE FOLLOWING RULES ARE TO BE UNDERSTOOD AS MISCONDUCT

- A. BEING UNDER THE INFLUENCE OF DRUGS AND ALCOHOL OR ANY OTHER SUBSTANCE.
- B. BEING THROWN OUT OF A GAME.
- C. STRIKING ANY CHILD.
- D. ABUSIVE CRITICISM OF ANY CHILD.
- E. SWEATING DOWN ANY CHILD SO THAT A PLAYER CAN MAKE THE WEIGHT OF THE WEEK. (IF CAUGHT BY THE LEAGUE IT WILL SUSPEND THE HEAD COACH FOR 1 YEAR AND FINE THE CLUB \$100.00 DOLLARS.
- F. KNOWINGLY PLAYING AN INELIGIBLE PLAYER: FOR EXAMPLE OVERWEIGHT PLAYER, INCORRECT AGES.

I FURTHER UNDERSTAND THAT I WILL ADHERE TO THE FOLLOWING RULES OR BE DISMISSED

- A. ABIDE BY THE DOCTOR'S DECISIONS IN ALL MATTERS OF A PLAYERS HEALTH AND INJURIES AND THE PHYSICAL ABILITY TO PLAY.
- B. STRIVE TO MAKE EVERY SPORT ACTIVITY A TRAINING GROUND FOR LIFE.
- C. TOGETHER WITH GAME OFFICIALS TO BE JOINTLY RESPONSIBLE FOR THE CONDUCT AND HAVE CONTROL OF MY TEAM, FANS AND SPECTATORS. ANY FAN WHO BECOMES A NUISANCE AND GETS OUT OF CONTROL MUST BE ASKED TO LEAVE THE PARK.
- D. ALWAYS ACCEPT THE DECISIONS OF THE OFFICIALS ON THE FIELD AS BEING FAIR, CALLED TO THE BEST ABILITY OF THE OFFICIALS. ALL THE COACHES MUST STAY OFF THE FIELD AND REMAIN UNDER CONTROL IN ORDER TO SET A GOOD EXAMPLE FOR THE PLAYERS AND THE FANS. A DECISION BASED ON A JUDGEMENT CALL SHOULD NEVER BE QUESTIONED. IN CASE OF A RULE VIOLATION BY THE OFFICIALS THEN I CAN PROTEST THE GAME.
- E. I UNDERSTAND THAT I AM RESPONSIBLE FOR THE PROPER CONDUCT OF THE COACHES, MY TEAM AND THE PARENTS. I UNDERSTAND THAT THE UTMOST IMPORTANT OBJECTIVE OF THE S.F.Y.F.L. IS YOUTH VALUE, FAIR PLAY AND GOOD SPORTSMANSHIP. I WILL ENDEAVOR TO BRING THIS CONCEPT TO THE FOREFRONT, WHILE DEVELOPING INDIVIDUAL SKILLS AND TEAM SPIRIT.
